Article 1.-

Article 2.

Formalities, procedures, and conditions for the provision of public services as stated in Article 1 of this Inter-ministerial Prakas shall be determined by Prakas of the Minister of Commerce.

Article 3.-

Any provisions that are in contradiction to this Inter-ministerial Prakas shall be abrogated.

Article 4.

Chief of Cabinet, Secretary General, Director General, Inspector General, Director of Department and Head of relevant units of the Ministry of Commerce and of the Ministry of Economy and Finance shall be responsible for the implementation of this Inter-ministerial Prakas according to their respective duties from the date of signature.
